## RE: PRODUCT VOLUNTARY RECALL- HANDFUEL Raspberry Pistachio Clusters 120 g

Dear Valued Retailers and Customers,

Please be advised that Handfuel is voluntarily recalling two lots of Raspberry Pistachio Clusters 120 g from the brand Handfuel due to the potential presence of Salmonella in the product. The contamination is linked to Iranian Pistachios, which have been banned by the Canada Food Inspection Agency (CFIA).

This is a voluntary withdrawal to the distribution/retail/consumer level.

- 2. Please review and complete the attached Return Coupon, even if you do not have any product remaining, no later than October 15, 2025.

- 4. If you have any affected product, please follow the steps:

  - Upon receipt of your coupon and proof of destruction, a credit note will be issued to cover the inventory that you have indicated on the coupon.
  - Upon the completion of the credit, please destroy/dispose the products in a manner that the products cannot be resold.
- 5. If you have any affected products from customer returns, please follow the steps as described in 4. at any time.
